Other Important Medicare Part D Announcements

Select nebulizer solutions for inhalation may be covered under Part B in 2012 for members that do not reside in a long term care facility. Members residing in a long term care facility will continue to have their nebulizer solutions covered under Part D.

Lipitor and Caduet will have new generic medications available in late 2011 or early 2012. When the generic drugs become available, brand name Lipitor and Caduet will no longer be covered. MVP will not remove Lipitor and Caduet from coverage until the generic products are in pharmacies.
