

Radiology Utilization Management, Claims Studio & Delegated Health Plans Procedure Code(s) Additions, Deletions, & Description Changes 2022

eviCore healthcare is recommending several updates to the managed code lists as a result of mid-year and 2022 American Medical Association (AMA) CPT[®] code additions, deletions and definition changes. The details of the updates are discussed in more detail below.

Should you participate in the applicable components of the listed eviCore programs, the outlined changes will be implemented effective January 1, 2022.

For codes revisions that are in scope, we recommend the following changes:

- Code Additions: AMA posted additions Mid-Year 2021 and for 01/01/2022, these additions will be effective 01/01/2022 with eviCore.
- **Code Deletions:** AMA termed these codes effective 12/31/2021. eviCore will no longer process requests for these procedure for dates of service after 12/31/2021.
- **Code Description Revisions:** AMA revised descriptions for 01/01/2022 with no result in material changes, notification is for information purposes only.
